23/86 Minutes

It was **RESOLVED** to approve the minutes of the ordinary parish council held on 17 April as a true and complete record of that meeting. (Proposed Cllr Thomas, seconded Cllr Tressler, all in favour).

23/87 Public Forum

Adam Dugmore advised that, with regard to planning item 1b (i.) – changing use to residential, the planning agent does make a correct factual statement in that there are two units there not one as may have been previously indicated and this should be born in mind when considering if the objection still stands as the net loss is zero. Item 9 - it is for the parish council to decide what they want to do with the stand (3m x 3m space) but a completed application form is required and it is likely that the carnival committee will waive the fee. In regard to the use of the pavilion car park for exhibitors, the request is that the carnival committee can open the gate to use the car park for exhibitors who are attending. The parking would be marshalled as far as possible to minimise the number of vehicle movements and maximise safety.

23/88 Planning Matters

- 1. Planning applications 22/01927/FUL and 22/01671/FUL
 - Cllr Kettle outlined the current position and advised that Stratford Distric Council (SDC) are treating the two applications as linked as approval for both are required for the Co-op to proceed. The Highways issues have been resolved and therefore the only issue is that the Parish Council has objected to application number 22/01927/FUL Change of use to residential) whilst supporting application number 22/01671/FUL (demolition of car showroom and adjacent bungalow and erection of convenience store with additional retail unit). With the planning objection lodged, the application would therefore need to go the Planning Committee and there are no objections from any other party.

Following discussion, it was **RESOLVED** to withdraw the parish council's objection to planning application 22/01927/FUL. (Proposed Cllr Kettle, seconded Cllr Thomas, four in favour, one against (Cllr Christian-Carter)).

2. Planning Application - **23/01044/FUL** 4 Hill View, Bishops Itchington, CV47 2YS - Single Storey Front Extension

It was **RESOLVED** that the parish council submits a response of 'No Reps' for planning application number 23/01044/FUL. (Proposed Cllr Thomas, seconded Cllr Tressler, all in favour).

23/91 Bishop's Itchington Carnival – 1 July 2023:

- 1. It was agreed that the parish council should have a stall at the carnival to promote the work of the parish council and to recruit new parish councillors. It was agreed that all the councillors and the clerk attend. Suggestions to put on the stall include:

- Set up is between 10am and 12.00noon, take down from 5.30pm onwards,

 Use of the playing fields car park for parking for exhibitors. It was **RESOLVED** to allow, on the day of the carnival (1 July2023) the use of the playing field car park for exhibitors parking. (Proposed Cllr Kettle, seconded Cllr Thomas, all in favour)

23/92 Environment & Properties

1. Children's Playground:

- Work started and is progressing well,
- Ongoing issue with children accessing the site,
- The question was asked as to whether there should be an official opening. It was suggested that as they do not have a role in the playground that the

new District Councillors be invited to open it and that some press coverage is arranged. Pick a date once it is completed,

- Adrian Cox, whose mothers house backs onto the play area has requested that the current low picket fence be replaced with a more durable high metal fence to stop the children accessing the property,
- CCTV in playground needs to be considered. This has previously been looked at and a spec was obtained,
- The possibility of a youth shelter be considered,
- An email has been received from a resident from the Knightcote Grange estate regarding the use of the 'private playground' whilst the refurbishment of the playground is undertaken. They are concerned about potential damage to equipment due to the high use and sometimes reckless behaviour by children using it.

Unfortunately, although the residents do have to pay for the up keep of the playground as per their deeds, it is not a private playground as it was an open space contribution to the village and a policy requirement for the developer to gain permission to build (Application 13/00914/FUL). It is public open space for the use of anyone in the village. If there is any criminal damage/vandalism to the equipment, it should be reported to the police. The clerk was asked to respond to the email.

2. Chapel Windows:

3. Hard Courts:

- Three quotes have been received two to replace the surface like for like and one to replace with astroturf,
- It was suggested that we write to the users and BISA asking what they would prefer,
- Questions were raised over the durability of the astroturf (lifespan) and the maintenance of it i.e., how often additional sand would be needed.
