### 20/100 Environment & Properties

#### 1 **Request to Erect Statue in Cemetery**

It was **RESOLVED** to refuse the application to erect a statue between two graves in the cemetery on the grounds that this does not comply with cemetery rules & regulations no 9 and would set a precedent if permitted.

#### 2 **Paving of Bin Area in Cemetery**

It was **RESOLVED** to approve the proposed plans for paving this area with the cost to be covered by a donation of £250.

**3 Removal of Gate & Stile, Scowcroft Drive**

Only one response had been received to the public consultation. While councillors understood the resident's concerns about increased footfall if the gate was removed, it was noted that the increase in the number of houses had already increased the use of the path. On balance, it was felt that the benefits of providing better access for all, outweighed concerns about increased footfall. It was therefore **RESOLVED** to remove the gate and stile. The clerk was asked to write to the resident to confirm that the trees on the green in Parrish Close remain the responsibility of the parish council.

It was **RESOLVED** to appoint Karen Stevens as the account administrator and approve the amendment to the bank mandate to take effect from 1 August 2020.
