It was advised that up to 31 March 2020, the parish council had a policy of setting money aside into specific reserves. Owing to the complexities of where we were last year this exercise was not completed therefore this year, what we would have done last year was taken into account, as well as what is required for the financial year up to 31 March 2022. The proposed Statement of Reserves as presented was discussed.

It was proposed that an additional line of reserves be included for the Children's Play Area with funding of £7,500 and that the Tennis Court Repair Fund be renamed 'Hard Court Replacement Fund' and the funding be increased by £14,666.77 to give a reserve of £20,000. The funding to be allocated to the Community Asset Fund to be

increased by £6,000 to give a reserve of £10,000 and that these amendments be funded from the Revenue Reserve (originally £26,924.07 leaving the Revenue Reserve at £4,924.07).

It was **RESOLVED** that, with the inclusion of the proposed amendments above, the Financial Report for year ending 31 March 2022 be accepted. (Proposed Cllr Kettle, seconded Cllr Gates, all in favour).
